

MINUTES OF A MEETING OF THE CRANBROOK & SISSINGHURST
NEIGHBOURHOOD DEVELOPMENT PLAN STEERING GROUP HELD ON 4th JUNE
2018.

The Clerk advised before the meeting proceeded that due to the confidential item to be discussed at the meeting. If members of the Steering Group have an interest this will mean that they cannot vote. As per the standing orders and code of conduct.

The Chairman read out the following statement:

07/18: June Exhibition:

N.W reported that feedback had been received from Richard Eastham (R.E) suggesting various possibilities on how to display the information collated so far to parishioners. A lengthy discussion took place around the vital information that needed to be displayed and the order in which the information should be presented. Lachlan Anderson Franks from AECOM hoped to have the report detailing housing need available for the exhibition. It was agreed that the following would be displayed –

- Current number of dwellings, allocations & targets
- Call for sites maps x 2
- Sustainability
- Scenarios including narrative & matrix
- Good housing for everyone – design, delivery and affordability
- Infrastructure & Projects
- This won't happen if you don't vote

Both T.K & M.H have offered to compile the maps and details needed for the exhibition. M.H offered to produce these for the NDP. The previous exhibition postcard responses to be displayed, with policy references attached, accompanied by a document containing draft policies (in brief). N.W advised she needed draft copies of the posters a week before the exhibition takes place, so they can be sent to R.E to view and print.

L.H offered to distribute leaflets promoting the exhibition around Cranbrook & Sissinghurst.
