18/03483/FULL

Sissinghurst Castle, Biddenden Road, Sissinghurst, Kent TN17 2AB Restoration of the Delos Garden.

The Parish Council recommended APPROVAL, subject to the views of the Conservation Architect. Proposed by Cllr. Bunyan, seconded by Cllr. Fermor and agreed.

18/03506/FULL

Flishingwell, Goudhurst Road, Cranbrook, Kent TN17 2PX Erection of a new barn structure for private equestrian development and storage of agricultural machinery and erection of a polytunnel

The Parish Council were not opposed in principle to the new barn development, however they recommended REFUSAL of this application for the following reasons:

- The height of the proposed barn was excessive
- Lack of detail and justification in the application.

Orchard View, Spongs Lane, Sissinghurst Kent TN17 2AH Replacement of existing barn for secure storage.

The Parish Council recommended APPROVAL.

#### 18/03646/FULL

Too Hoots, Spongs Lane, Sissinghurst, Cranbrook, Kent. TN17 2AH Alterations/Extensions and remodeling of the existing property to create a two Storey dwelling.

The Parish Council recommended APPROVAL.
